- 5. **No Liability:** The Owner understands that once the Dog is surrendered, the Rescue assumes all responsibility and liability for the Dog. The Owner releases and discharges the Rescue from any claims or liabilities arising from the Dog's future actions, health, or placement.
- 6. **No Financial Compensation:** The Owner acknowledges that they are surrendering the Dog without any expectation of financial compensation, reimbursement, or adoption updates.
- 7. **Truthful Representation:** The Owner affirms that all information provided in this Agreement is accurate and complete to the best of their knowledge. Any false representation may result in legal consequences.
- 8. **Indemnification:** The Owner agrees to indemnify and hold harmless the Rescuer from any claims, damages, or liabilities arising from the Dog's history prior to surrender.
